## **TO POTENTIAL BIDDERS**

**SUBJECT:** Changes and additions to the tender documentation

Pursuant to Article 63. Paragraph 2 of the Law on Public Procurement, we are publishing the changes and additions to tender documentation in **open procedure** of the public procurement: **Reconstruction of Boiler Room "ZASTAVA" with the purpose of replacing a part of the capacity of coal-fired boilers with the combined natural gas-powered and heavy fuel oil-powered boilers, Phase I** no. 1.1.47 / 2017

The tender documentation changes as follows:

- On page 2 under "Content", item 20 is added - Equipment producer's statements and item 22 – Public Procurement Contract Model
- On pages 4 and 57 the description under position number 1 in table number 1 - Boiler is changed
- On page 8 under the Technical description under number 1 - the boiler, we change the description in the first paragraph.
- On pages 33, 34, 35 and 36, "A" has been supplemented with technical capacity evidence
- On page 36, under "B", the Evidence of the Technical Capacity is added "Declaration of the goods manufacturer that the service shops/centers listed in the statements of technical capacity of authorized service are shops/centers authorized by the manufacturers of goods",
- The page number 36 the number of services that are requested is changing and "on the territory of the Republic of Serbia" is deleted
- On page 37, under the evidence of the Human resources Capacity, a photocopy of the diploma is added,
- On page 37 the business-financial capacity has been changed
- On page 38 under "notes", item 1 - If the bid is submitted with the subcontractor, the first paragraph is changed
- On page 39 under item 3 - submission of evidence paragraph 4 has been changed
- On page 43 of the aforementioned statements of the producers of goods are added to the "Obligatory content of the bid",
- On page 43 under the "Obligatory content of the bid", the Public Procurement Contract Model arising from the Framework Agreement has been added
- On page 45, item 11 is changed – Price, Instructions to Bidders how to make an offer
- On page 45 the description under item 12 is changed. Financial security funds "for performance of the job"
- On page 50 under item 18. The request for the protection of rights the fourth paragraph is changed
- On page 56 under the Offer Form, item 3 is changed - the method, deadline and terms of payment

- On pages 76, 77, 78 and 79, the Technical Capacity Statement Forms are changed
- On pages 87, 89 and 91, the customer confirmation forms for boilers, burners and exchangers have been changed,
- On page 95 changed the Bank Statement on the intention to issue a bank guarantee
- On pages 102, 103, 104 and 105, the forms of the aforementioned statements of the producer of goods are added,
- Article 4 of the Framework Agreement Model is amended on page 108,
- Article 9 of the Model Framework Agreement has been amended on page 111
- On page 116 under Article 16 of the Framework Agreement Model, item 8 has been added- Equipment producer's Statesments.
- At the page number 118 the Public Procurement Contract Model arising from the Framework Agreement.

Bidders must adjust their offers to the specified changes in the tender documentation. Since the tender documentation is changed to more than 8 days until the expiration of the deadline for submission of bids, the deadline for submission and opening of tenders WILL NOT be extended and will remain as it is until now - 22.12.2017. 10:00 am and 10:30 am.
